

#### AMENDED ARTICLES OF INCORPORATION

OF

#### ASIA UNITED BANK CORPORATION1

#### KNOW ALL MEN BY THESE PRESENTS:

That we, all of legal age and a majority of whom residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Republic of the Philippines.

#### AND WE HEREBY CERTIFY, That:

FIRST:

That the name of the corporation shall be:

#### ASIA UNITED BANK CORPORATION

SECOND: The purposes for which the corporation is formed are to perform commercial banking functions, and within the context of a financially viable banking institution, to provide banking services, to develop agriculture, commercial and industrial enterprises and other business project; and with prior approval and authorization of Bangko Sentral ng Pilipinas and/or Monetary Board; to carry on a general trust business; to operate a foreign currency deposit unit; to perform expanded commercial banking functions; to invest in allied undertakings, financial and non-financial; to do and perform such acts as are necessary and incidental to the purposes for which the corporation is organized, and by virtue thereof, to have and exercise all rights, attributes, powers and privileges, together with the assumption of all the duties and obligations of a commercial bank or a commercial bank with expanded banking authority as provided for in the General Banking Act, as amended, and other related laws.

THIRD: Its principal office and place of business shall be <u>at Joy~Nostalg Center</u>, <u>17 ADB Avenue</u>, <u>Ortigas Center</u>, <u>Pasig City</u>, <u>Metro Manika</u>.<sup>2</sup> It may open and/or maintain other branches, agencies or other offices at such places in the Philippines or abroad as its Board of Directors may deem advisable, with the prior approval of the Monetary Board of the Bangko Sentral ng Pilipinas.

FOURTH: The term for which the said corporation is to exist is Fifty (50) years from and after the date of incorporation.

TENTH: No stockholder of the corporation shall, because of his ownership of stock, have a pre-emptive or preferential right to purchase, subscribe for, or take any stock or part of the notes, debentures, bonds or other securities convertible into a carrying option or warrant to purchase stock of the corporation issued, optioned or sold by it after its incorporation. Any part of the capital stock and any part of the notes, debentures, bonds or other securities convertible into carrying option or warrant to purchase stock of the corporation may be issued, optioned for sale and sold or disposed of by the corporation


pursuant to the resolution of its board of directors for such person and upon such terms as may to such board seem proper without first offering such stock or securities or any part thereof to existing stockholder.<sup>6</sup>

ELEVENTH: A stock option plan may be adopted by the corporation subject to the rules promulgated by the Securities and Exchange Commission as well as the limitations imposed by the Bangko Sentral ng Pilipinas.

TWELFTH: No issuance or transfer of stock of the comporation which shall reduce the ownership of Filipino citizens to less than the percentum of capital stock required by law to be owned by Filipino citizen shall be allowed or permitted to be recorded in the proper books of the corporation. This restriction shall be printed or indicated in all the stock certificates to be issued by the Corporation.

THIRTEENTH: Mr. Jacinto L. Ng, Sr. has been elected by the subscribers as the Treasurer of the Corporation to act as such until his successor is duly elected and qualified in accordance with By-Laws, and as such Treasurer, he has been authorized to receive for and in the name of the corporation, all subscription paid by said subscribers.

- (a) Article Third To amend the principal office address from "in the National Capital Region, also known as Metro Manila" to "at Joy~Nostalg Center, 17 ADB Avenue, Ortigas Center, Pasig City, Metro Manila."
- (b) Article Sixth to add the phrase "and shall have such number of Independent Directors as provided in all applicable laws and regulations."

#### 1) BY-LAWS

- (a) Article I, Section 1.1 to refer to the Articles of Incorporation with regard to the principal address.
- (b) Article III, Section 3.2 and 3.3 to allow stockholders to hold scripless shares, allow the Assistant Corporate Secretary to countersign Stock Certificates alternative to the Corporate Secretary and the appointment of a stock transfer agent.
- (c) Article V, Section 5.1 to change the schedule of the Annual Stockholders' Meeting to "fourth Friday of June" to allow time for the preparation of reports in compliance with the reportorial requirements under the Securities Regulations Code and other applicable laws and regulations.
- (d) Article V, Section 5.3 and Article VII, Sections 7.5 and 7.6 to allow notices of meetings to be sent by e-mail and other electronic means in addition to other written means.
- (e) Article V, Section 5.7 and Article VII, Section 7.10 deleted
- (f) Article VII, Sections 7.12-A, 7.12-B and 7.12-C; and Article VIII, Section 8.10-A added to implement and mirror the provisions of the Securities Regulations Code, its implementing rules, and the Code of Corporate Governance on committees and the compliance officer.
