Item 9. Other Events/ Material Information:

At the Board meeting today at 10 am, among others, the following were taken up:

- 1. <u>Creation of AUB Peso Money Market Fund</u>: Having received Bangko Sentral ng Pilipinas approval for the establishment of the AUB Peso Money Market Fund, the Board ratified and authorized the creation of the AUB Peso Money Market Fund subject to the conditions stated in the BSP letter dated October 10, 2013. (Attached as Annex "A")
- 2. Acquisition of Assets and Assumption of Liabilities of the Cooperative Bank of Pampanga, by the Rural Bank of Angeles, Inc.: Having received approval-in-principle from the Bangko Sentral ng Pilipinas, the Board ratified the purchase by the Rural Bank of Angeles, Inc. of all assets, and the assumption of all liabilities, of the Cooperative Bank of Pampanga. For said purpose, AUBC authorizes the release of funds to recapitalize RBAI in such amount as necessary for the rural bank to meet the 15% CAR requirement under SPCB Plus, but in no case lower than Php400M.
- 3. <u>Issuance of Long-Term Negotiable Certificates of Time Deposits (LTNCDs)</u>: Having received Bangko Sentral ng Pilipinas approval, the Board ratified its resolution and authorized the issuance to the public of LTNCDs up to a maximum aggregate principal amount of Php5.0Billion in one or more tranches over a period of one year.
- 4. <u>Accreditation of Additional Collection Agencies</u>: The Board approved the accreditation of four additional collection agencies to assist in the collection of retail accounts; the agencies are:
 - a) Arquillo De La Cruz & Associates Law Office
 - b) Capital Collections and Recovery Specialist Inc.
 - c) Receivers and Liquidators Inc.
 - d) RGS Recovery Management and Collection Services, Inc.

The Corporation fully undertakes that it shall furnish the Honorable Exchange all material documentation and filings for the aforementioned resolutions.
