Background / Description

- At the meeting of the Board of Directors held on 25 April 2014, the Board of Directors of Asia United Bank Corporation (AUB) approved, among others, the proposed amendments to the Articles of Incorporation and By-Laws, subject to the approval of the Bank's stockholders in accordance with the Corporation Code and its By-Laws.
- 2. During the annual stockholder's meeting of AUB held on 9 June 2014, the shareholders representing at least three-fourths (3/4) of the capital stock of the corporation, as required by the corporation's existing By-laws, approved the proposed amendments to corporation's Articles of Incorporation and By-laws as described in detail in the corporation's Information Statement for 2014.
